It is hard to believe that this November, Neighbor Ride will complete its fifth year of operations. So much has happened in those five years; and being voted as the 2008 Best of Howard Charity/Non-Profit by the readers of Howard Magazine was a wonderful acknowledgement of the hard work and commitment of our staff and volunteers.

With a solid infrastructure in place, we continue to focus on growth. That attention is paying off. In the last year, we provided 5,994 trips for seniors in the community, representing a four percent growth over the prior year. In total, Neighbor Ride has provided over 21,400 trips for passengers since beginning operation in November 2004.

Over two hundred new passengers registered in FY09 and fifty-six volunteers were recruited. Whereas performance and growth are key measures, we are also extremely proud of the reputation we have achieved with our passengers and others in the community.

In the fall we will engage in a strategic business planning process to clarify where we want to go in the future and the path we will take to get there.
