PRESIDENT'S MESSAGE

The Neighbor Ride fiscal year ending June 30, 2014 was a banner year as we began planning the *Million Miles of Smiles Anniversary Celebration* in recognition of ten years of providing volunteer-driven supplemental transportation for older adults in Howard County.

With Sen. James Robey serving as the Honorary Chairperson, staff and board members began working on the anniversary-year events in the fall of 2013. The April 11, 2014 kickoff event at The Kittamaqundi Community Church's Oliver's Carriage House was attended by supporters, volunteers and passengers. In May, Neighbor Ride partnered with the Howard County Police Department and the Howard County Office on Aging to offer a free CarFit event. It gave adult drivers a free car evaluation from trained technicians to ensure that their cars "fit" them for comfort and safety.


June, July and August followed with free Ice Cream Socials at three senior housing complexes, hosted by The Shelter Group with gallons of delicious ice cream donated by Wegmans. Staff and Board members scooped hundreds of tasty dishes for residents and community members.

At the end of the calendar year, the planning that began in the 2014 Fiscal Year culminated in a wildly successful Founders' Open House, honoring Neighbor Ride's original Board members and first Board President, Judy Pittman. Colleen Konstanzer was honored as the first Executive Director and Carol Jackson as the first Bookkeeper.

This anniversary year, we also introduced a new type of business partnership, focused on recruiting volunteers and passengers by promoting Neighbor Ride through organizations' normal channels of communication. Howard Community College was the first to pledge this type of support and now continually promotes Neighbor Ride to its students, faculty, and staff.

These events marking the *Million Miles of Smiles* were supported by individuals and businesses sharing Neighbor Ride's dedication to both providing supplemental transportation for older adults and offering meaningful volunteer opportunities for community members. 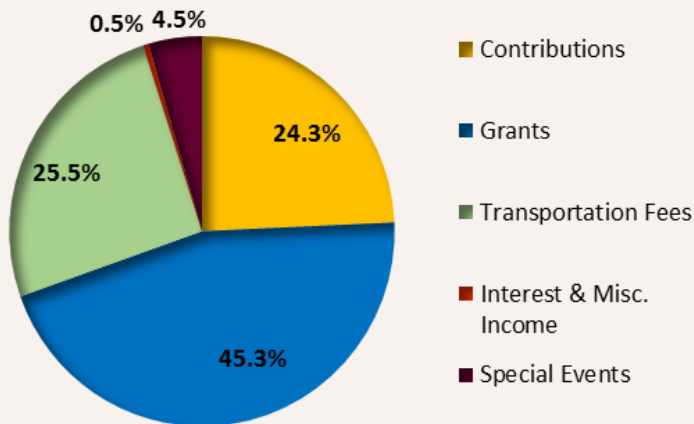

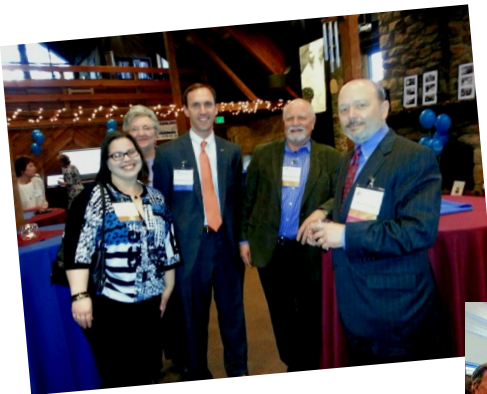
